WATER USER AGREEMENT

This agreement entered into between the Lyon County Water District, a water district organized under the supervision of the Kentucky Revised Statues, herein after call the "District" and User of the District, herein after called "User"

WITNESSETH

Whereas, the User desires to purchase water from the District and to enter into a water users agreement as required by the Bylaws of the District.

Now therefore, in consideration of the mutual covenants, promises, and agreements herein contained. It is hereby understood and agreed by the parties hereto as follows:

The District shall furnish, subject to the limitation set out in its Bylaws and Rules and Regulations now in force or as hereafter amended such quantity of water as User may desire in connection with User's occupancy of the following described property

The User shall install and maintain at his own expense a service line, which shall begin at the meter and extend to the dwelling for place of use. The service line shall connect with the distribution system of the District at the nearest place of desired use by the User, provided the District has determined in advance that the system is of sufficient capacity to permit delivery of water at that point.

The User agrees to comply with and be bound by the Articles, Bylaws, Rules and Regulation of the District, now in force, or as hereafter duly and legally supplemented, amended or changed. The User also agrees to pay for water at such rates, time and place as shall be determined by the District and agrees to the imposition of such penalties for noncompliance as are now set out in the District Bylaws and Regulations, or which may be thereafter adopted and imposed by the District.

The User agrees to pay a pre-paid bill in the amount of \$__0.00_____. In the event service to the User is terminated, either voluntarily by the User, or by the District, for cause, the pre-paid bill shall be held and applied by the District to any unpaid balance then owing on the User's account. Should the account be fully paid at the time of termination of service to the User, the pre-paid bill shall be refunded by the District, within a reasonable time thereafter.

The District shall purchase and install a water meter with a cutoff valve to each service. The District shall have exclusive right to use such cutoff valve and water meter. The District shall have final authority in any question of location of any service line connected to its distribution system.

The User agrees that no other present or future source of water will be connected to any water lines served by the District and will disconnect from his present water supply prior to connection to the District's system and shall eliminate their present or future cross-connection in his system.

The User shall connect his service lines to the District's distribution system and shall commence to use water from the system on the date the water is made available to the user by the District. Water charges to the User shall commence on the date service is made available, regardless of whether the User connects to the system.

This contract shall be effective when water is available from the system proposed to be constructed adjacent to the Users property of thirty-six (36) months from date, whichever is shorter. In the event water is not available to the User with said period, this contract shall be void and the User's deposit remitted.
